

Please be advised that on Monday, June 24, 2019, at 6:30 P.M. prevailing time, at the Pocopson Township Building, 740 Denton Hollow Road, West Chester, PA 19382, the Pocopson Township Board of Supervisors will conduct a public hearing to consider, and immediately thereafter during its regular meeting decide whether or not to adopt, an ordinance titled: **“AN ORDINANCE OF THE TOWNSHIP OF POCOPSON, CHESTER COUNTY, PENNSYLVANIA, TO AMEND THE SPECIAL EVENTS CHAPTER OF THE CODE OF THE TOWNSHIP OF POCOPSON AND OTHER MISCELLANEOUS PROVISIONS.”** Section 1 amends Section 1 “Definitions” by the deletion of definitions for “community event” and “outside support services”. Section 2 amends Section 1 “Definitions” by amending the definition for “special event”. Section 3 amends Section 2 “Permits Required” to eliminate references to community events. Section 4 amends Section 3 “Application” to revise the application requirements. Section 5 amends Section 4 “Township Review” to modify the review process. Section 6 deletes Section 5 “Notification” in its entirety and creates new Section 5 “Approval or Denial” to provide for a process for approval or denial of permit applications. Section 7 amends subsection 6.A to remove reference to community events. Section 8 amends subsection 6.B to remove reference to subcontractors. Section 9 amends subsection 6.I to remove reference to a vendor agreement. Section 10 amends subsection 6.N to modify the time period. Section 11 deletes subsections 6.F, G, K and O in their entirety. Section 12 amends subsections 7.B, C and D to change the number of business days to take certain actions. Section 13 amends Section 8 “Revocation of permit” to modify time periods and clarify internal references. Section 14 amends Section 9 “Appeals” to clarify time periods. Section 15 deletes Section 11 “Records” in its entirety. Section 16 provides for severability if any sentence, clause, section, or part of this Ordinance is held to be unconstitutional, illegal, or otherwise invalid. Section 17 repeals all ordinances or parts of ordinance conflicting or inconsistent herewith. Section 18 permits General Code to make nonsubstantive formatting and numbering changes. Section 19 provides for the Ordinance to become effective five days after enactment. A complete copy of the proposed Ordinance may be examined and copies obtained (for the cost of reproducing same) at the Township Building, Monday through Friday, 9:00 A.M. to 12:00 P.M.. In addition, attested copies of the Ordinance are on file at the Daily Local News, 390 Eagleview Blvd., Exton, PA 19341 and the Chester County Law Library, 201 W. Market Street, Suite 2400, West Chester, PA 19380 where the same can be examined without charge.
