RESOLUTION NO. 2010-14
WINTER PARKING

WHEREAS, the Code of Pocopson Township, Chapter 221, Vehicles and Traffic, sets forth the provisions for winter parking in the Township and the authority to remove and impound illegally parked vehicles that interfere with snow removal, salting, cindering, or plowing operations; and

WHEREAS, the Township shall designate in accordance with Section 221-3 an approved storage facility as a pound for the storage of impounded vehicles; and

WHEREAS, the Township shall required said facility to post a certificate of insurance in an amount determined by the Township for indemnification of the owner of any such impounded vehicle against the loss thereof or injury or damage thereto while in the custody of such storage facility; and

WHEREAS, the name of the tow service or operator shall be displayed on both sides of the truck in accordance with Pennsylvania Vehicle Code Section 4573; and

WHEREAS, the towing and impounding will be in effect when the Township determines that a damaged or unattended vehicle constitutes a hazard or interference with snow removal, salting, cindering, or plowing operations, or as otherwise specified n Section 222-1, as amended.

NOW THEREFORE, BE IT RESOLVED THAT the Board of Supervisors of Pocopson Township hereby designates and approves the following tow service and storage facility for vehicles parked illegally that interfere with snow removal, salting, cindering, or plowing operations: Young's Garage, 1022 Lenape Road, West Chester, Pennsylvania 19382; and

BE IT FURTHER RESOLVED THAT the Board of Supervisors shall required the approved tow service and storage facility to file a certificate of insurance with the Township as a named insured in the amount of four million dollars (\$4,000,000); and

BE IT FURTHER RESOLVED THAT in accordance with Section 221-4, the charges for towing and storage of any vehicle removed and impounded under the authority of Township Code shall be as follows: \$125.00 to tow from any location in Pocopson Township to Young's Garage Storage facility with an additional charge of \$25.00 per day for each day that the vehicle is not claimed.

If any sentence, clause, section or part of this Resolution is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared the intent of the Township Board of Supervisors that this Resolution would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

All Resolutions, or parts of Resolutions conflicting with any provisions of this Resolution are hereby repealed and of no force or effect from this date.

ENACTED AND RESOLVED this 22nd day of March, 2010. This Resolution shall take effect within 180 days of passage.
