## Board of Supervisors Reorganization Meeting Tuesday, January 7, 2013, 7:30 P.M.

In attendance: Stephen R. Conary, Georgia F. Brutscher, Ricki Stumpo.

- **1. Call to Order:** Conary called the meeting to order at 7:30 p.m. and wished those in attendance a Happy New Year.
- 2. Public Comment: none.
- **3. Reorganization of the Board of Supervisors:** Conary moved to nominate Brutscher to serve as Temporary Chair and Susan Simone as Temporary Secretary of the Board of Supervisors; motion carried. Brutscher moved to nominate Conary as Chair of the Board of Supervisors; motion carried. Conary moved to nominate Brutscher to serve as Vice Chair; motion carried.
- **4. Appointment of Employees and Personnel:** Stumpo moved, Brutscher seconded, to appoint the following Township Personnel at a pay rate consistent with the 2013 Township Budget: Susan Simone as Township Administrative Secretary; Peggy Lennon as Township Treasurer; Mark Knightly as Public Works Director and as Roadmaster; Mike Cialini and Ron Miller as Public Works Crew Members; motion carried.

Brutscher moved, Conary seconded, to appoint Ricki Stumpo as Receptionist at a pay to be determined by the Board of Auditors; motion carried.

Conary moved, Stumpo seconded, to appoint Richard Jensen as Zoning and Code Enforcement Officer at the rate approved in November 2011; motion carried. Brutscher moved, Stumpo seconded, to appoint Richard Jensen as Fire Marshall with a term to expire December 31, 2013 or until a replacement is named; motion carried.

Board noted for the record the appointment of Richard Jensen as Emergency Management Coordinator until a successor is named by the Governor.

Stumpo moved, Brutscher seconded, to appoint Peggy Lennon as the PMRS - Pension Plan Administrator with a term to expire December 31, 2013 or until a replacement is named; motion carried.

Brutscher moved, Stumpo seconded, that the Township obtain a Treasurer's Bond in the amount of \$2.6 million dollars; motion carried.

Brutscher moved, Stumpo seconded, to appoint Peggy Lennon as Township representative and Carol Haaf as alternate representative to the County Tax Collection Committee; motion carried.

- **14.** Conary moved, Brutscher seconded, to table the appointment of a member of the Board of Supervisors as the voting delegate to the Conventions sponsored by the Pennsylvania State Association of Township Supervisors and the Chester County Associations of Township Officials; motion carried.
- **15. Township Holidays and Meeting Dates:** Brutscher moved, Conary seconded, to establish 2013 holidays for the Township as follows:

Planning Commission – the 3<sup>rd</sup> Wednesday of each month except August at 7:30 P.M. Historical Committee – the 2<sup>nd</sup> Wednesday of each month at 7:30 P.M. Parks, Recreation and Trails Committee – the 2<sup>nd</sup> Thursday of each month at 7:30 P.M.

Motion carried.

**16. Supervisor Liaisons to Township Committees:** Following discussion, the Board agreed to Brutscher serving as Liaison for the following Committees: *Historical, Agricultural Security Area and Barnard House Steering.* Stumpo for the following: *Parks, Recreation and Trails and Stream Team.* Conary for the *Planning Commission.* 

## 17. Resolutions:

**Resolution 2013-1**: Conary moved, Brutscher seconded, to adopt Resolution 2013-1 establishing boundaries for fire protection in the Township between Longwood Fire Company and Po-Mar-Lin Fire Company and designates Longwood Ambulance as the EMS provider to the Township and Avondale State Police Barracks as the police protection for the township; motion carried.

**Resolution 2013-2:** Conary moved, Brutscher seconded, to adopt Resolution 2013-2 in accordance with the Second Class Township Code establishing the following depositories for Township Funds: Susquehanna Bank, Meridian Bank, PLGIT (Pennsylvania Local Government Investment Trust) for select investment accounts, and WSFS Bank; motion carried.

**18. Other business:** Board signed letters of acknowledgment for donations to the Locust Grove School House from Bruce Yelton and the Fair Play Foundation. Stumpo noted the absence of a Founders Day Committee Chairman and suggested suspending the event for 2013. She reported that the PRT Committee is interested in sponsoring three events in Pocopson Park during 2013. Stumpo suggested and the Board agreed that the Township consider sponsoring an open house in 2013 inviting the public to visit all township facilities. Board discussed steps to fill appointment to the Bayard Taylor Library Board. Conary stated that he would not be seeking re-election.

**Motion:** Conary moved, Brutscher seconded, to approve signing of the Second Amendment to Private Driveway Agreement for the Koehler Property; motion carried. **Motion:** Conary moved, Brutscher seconded, to table appointment of a Founders Day Committee and to discuss suspending the event for 2013 during the January 28<sup>th</sup> regular meeting; motion carried.

- 18. Treasurer's Warrants: Conary moved, Stumpo seconded, to approve the Bill Payment Lists for December 18, 2012 January 7, 2013 recommended for payment by the Treasurer; General Fund: 24 bills paid totaling \$21,208.11; 5 debit card charges totaling \$250.18; 1 debit card credit for \$98.89; Highway Aid: 4 bills paid totaling \$5,769.96; Parks Recreation and Trails: 3 bills paid totaling \$452.83; Road Improvement Fund: 1 bill paid for \$20,129.46; motion unanimously approved.
- **19. Minutes of December 17, 2012 and Special Meeting December 26, 2012:** Conary moved, Brutscher seconded, to approve the Minutes of December 17, 2012; motion carried. Conary moved, Brutscher seconded, to table approval of the December 26, 2012 Special Meeting Minutes; motion carried.
